The Helicopter Safety Alliance's (HSA) mission is to bring safety to an underserved part of the helicopter community: small operators of helicopters. This sector operates approximately 10,000 helicopters, or two-thirds of the US fleet.

The majority of the operators in this sector simply do not have the financial resources, time, or experience to implement their own robust safety programs. They often do not travel to the large helicopter events such as Heli-Expo or the CHC Safety Summit to obtain valuable training and to network with vendors or other operators. Less than 5% of the audience at a recent HSA event reported attending any large conference.

The Helicopter Safety Alliance (HSA) hosts Helicopter Safety Stand-Downs that provide continuing education for managers, pilots, and maintainers of small operations. Bringing these three disciplines together creates the right environment for learning about current trends in aviation safety and networking with peers.

Regular participation in peer-to-peer education events like this is associated with a **significant decrease in the likelihood of having an accident**. Additionally, we believe that by managing the risks associated with helicopter operations, the threat of accidents can be further reduced.

There is **no charge to attend**, and the HSA Helicopter Safety Stand-Downs are held **in conjunction with the local FAASTeam**. WINGS and AMT credits are available for attending.

An HSA Helicopter Safety Stand-Down **begins at 0730** with an hour of networking over coffee and danish. The general session starts at 0830 and includes several speakers addressing attendees about ways to improve safety in small operations.

HSA provides lunch and another networking opportunity from 1200-1300. After lunch we split into three breakout groups to cover subjects specific to operators, pilots, and maintainers. The Stand-Down typically **breaks up at 1600**. Attendance ranges from 80 to 150.

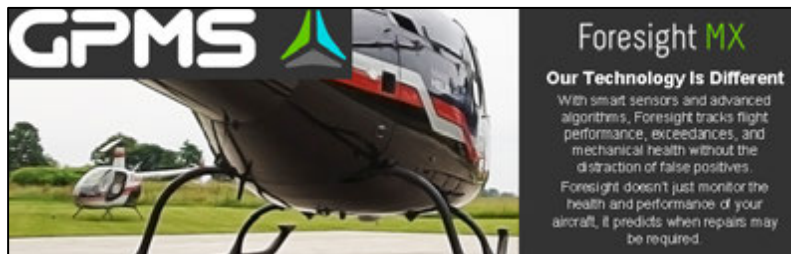
